Objective 1.

The purpose of the policy is to provide guidance relating to the payment/reimbursement of personal professional subscription fees of recognised accounting bodies.

2. Scope

Includes membership of recognised professional accounting bodies.

Applicable to 3.

All Finance staff who, in line with their current job description, are members of recognised professional accounting bodies.

Policy 4.

The operational unit will pay/reimburse the annual subscription fees for those staff who are full registered members of one of the following recognised professional accounting bodies.
